How to Use - Outdoors	
As a Perimeter Treatment	Apply early in the season or when insects appear. Apply in a band up to 7 feet wide around the outside perimeter of the building. Also treat the building foundation to a height of 2 feet where pests are active and may find entrance. Thoroughly and uniformly wet the band area.  Concentrate treatment at visible ant trails as well as cracks or crevices where ants may enter the structure. The surface to be treated should be dry at the time of application.
